- The minimum BPAC contribution that will be matched is \$100.00.
- Boeing reserves the right to decline to match any donation to an organization (a) that denigrates or advocates discrimination or violence toward any racial, ethnic or cultural group or (b) whose practices are, in the good faith determination of the company, otherwise inconsistent with company goals and policies.
- Individual BPAC contributor may not receive a tax deduction or other benefit from the recipient charity by virtue of the charitable donation(s).
- BPAC matching donations do not affect the contribution limits of The Boeing Company Matching Gift Program(s).

- Employees may request funds to the following types of U.S. based 501(c)(3) non-profit organizations:

  - Civic
  - Educational Institutions

## ADMINISTRATION

- If you contribute to BPAC via payroll deduction, the matching donation(s) for the current year's payroll deductions will be made at the beginning of the following calendar year.
- If you contribute to BPAC via personal check, the matching donation will be made in July of that year or in the beginning of the following year depending on the date the check is received.
- Forms must be processed within 1 year of the date of the BPAC contribution. After 1 year the BPAC contribution is no longer eligible for matching.
- Participants will be notified by email or letter when donations have been made.
- The Boeing Company reserves the right to suspend, limit, change, revoke or terminate this program at any time.
- All determinations concerning program eligibility criteria or participation are solely within the discretion of the Boeing Company.
